Product Warranty for Decor Walther-Branded Products**

To whom it may concern,

Decor Walther Einrichtungs GmbH (hereinafter referred to as the "manufacturer") warrants towards the end customer (hereinafter referred to as the "customer") in accordance with the following provisions that the Decor Walther- branded products (hereinafter referred to as the "product") delivered to the customer in Finland (hereinafter referred to as "geographical scope") within a period of two (2) years from delivery (warranty period) will be free from defects in material or workmanship. The manufacturer will, at its own discretion, correct the defects claimed in this way at his own expense by repairing or delivering new or refurbished parts. The warranty does not extend to replaceable bulbs (parts not covered). Other claims of the customer against the manufacturer, in particular for damages, are excluded. The contractual or legal rights of the customer towards the respective seller are however not affected by this warranty.

Claims from this warranty only exist if

- the product shows no signs of damage or wear and tear caused by use that deviates from the normal use and specifications of the manufacturer (according to the user manual), and/or care instructions,
- the product has no characteristics that suggest repairs or other interventions by workshops not authorized by the manufacturer,
- only accessories authorized by the manufacturer have been installed in the product,
- the serial number has not been removed or made unrecognizable.

Warranty claims can only be asserted against the manufacturer on presentation of the original invoice with the date of purchase within a period of two (2) months after the warranty event or, if defects are not immediately apparent, within two (2) months of their discovery. The costs of sending and returning the product are borne by the manufacturer. However, if the manufacturer or the customer service responsible has given the customer a specific freight company for the submission and the customer uses another freight company, the manufacturer will not be responsible for the costs of the submission.

This warranty applies to the above-mentioned extent and under the above-mentioned conditions (including the presentation of proof of purchase in the event of resale) for any future owner of the product who is based in the geographical scope of this warranty.

This warranty is subject to the laws of the Federal Republic of Germany under exclusion of the conflict of laws rules of its international private law and under exclusion of the CISG.
